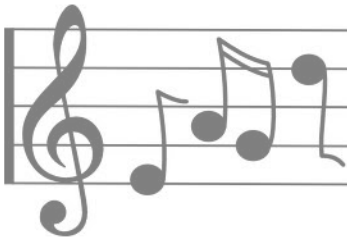


# Sr. Chorus at Lang Ranch

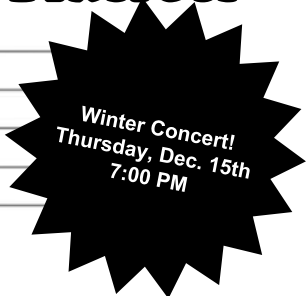


## Dates and times

**Classes:** Students in grades 3rd, 4th, and 5th are eligible for the Sr. Chorus. Classes begin on **Sept. 22, 2011 - Jan. 12, 2012** on Thursdays. Rehearsals will be held in the multi-purpose room.
